EU/EFTA citizens wishing to carry out a **regulated professional activity** in Switzerland for a **maximum of 90 working days** per calendar year must submit a declaration in the SERI [online portal](#) before providing the service. Detailed information on the entire procedure can be found on the following website: www.sbf.admin.ch/edeclaration > Procedure and Duration

If the profession or activity is not on this list, no declaration needs to be submitted to SERI.

Note: **All service providers** from the EU/EFTA must declare their period of service and place of work before commencing the provision of services: [Notification procedure for short-term work in Switzerland](#). The confirmation of notification is a mandatory requirement in order to entry in Switzerland.
