

Next steps

V	The reception service submits the request to the university's delegate of the Federal Commission for Scholarships for approval and forwards the complete request with the delegate's statement to the FCS Secretariat.
\checkmark	If the application is about an exceptionally long lasting field trip of more than 6 months, the executive board of the Federal Commission for Scholarships will treat such application.
\checkmark	The FCS Secretariat communicates the final decision to the PhD-scholarship holder with copies to the academic supervisor, the university's delegate and the reception service.
V	The scholarship holder contacts the responsible person at the reception service of the university after returning to Switzerland within 5 days.

Disclaimer

Only planned field trips announced with the submitted research proposals are acceptable.

As indicated in the "Instructions for scholarship holders" it is mandatory to request the approval of the reception service when traveling abroad or in case of any other absence from the place of study for more than two weeks. After returning to Switzerland, the scholarship holder contacts the reception service. For field trips, the approval of the Federal Commission for Scholarships is required.

The requests for fieldwork lasting exceptionally longer than 6 months during the whole PhD scholarship are treated as exceptional cases and have to be approved by the FCS executive committee.

If more than one field trip is required during the PhD scholarship - this form may be used for all requests once.

If the field trip is approved the scholarship will continue during the fieldwork. Beyond the grant, there is no financial support for fieldwork by the Federal Commission for Scholarships.
