<b>Scholarship</b>	⇒ Swiss Government Excellence PhD Scholarships for foreign students
<b>Offered by</b>	⇒ The Swiss Government via the Federal Commission for Scholarships for Foreign Students FCS
<b>Objectives</b>	⇒ To enable selected applicants to undertake a PhD at one of the 10 Swiss cantonal universities, the two Swiss federal institutes of technology or the Graduate Institute.

<b>Federal institutes of technology</b>	⇒ <a href="#">Swiss Federal Institute of Technology Lausanne (EPFL)</a> ⇒ <a href="#">Swiss Federal Institute of Technology Zurich (ETHZ)</a> ⇒ <a href="#">Research Institutes of the ETH Domain (PSI; WSL; EMPA; EAWAG)</a> ⇒ <a href="#">Graduate Institute of International and Development Studies (IHEID)</a>
<b>Validity</b>	⇒ The scholarship is valid only for full-time PhD studies in Switzerland. It is not valid for mixed PhD programmes (part time in Switzerland and part time in another country). ⇒ "Cotutelle de these": PhD students with an ongoing or planned doctoral project that is carried out within the framework of a formalized agreement between two universities ("cotutelle de thèse" cooperation between a Swiss and a foreign university) and under the joint direction of two supervisors are eligible for a 12 month research fellowship only.
<b>Target group</b>	⇒ Highly qualified postgraduate students (possessing the required degrees) from all academic fields (except: higher physics, advanced computer simulation, computer sciences, nuclear engineering, aeronautic engineering and space technology) as well as young medical doctors.

<b>Duration</b>	⇒ 12 months (starting in September) prolongable up to 36 months based on the achieved academic results.
<b>Amount and additional allowances</b>	⇒ The scholarship amounts to a monthly payment of CHF 1'920. ⇒ There are no family allowances. ⇒ No financial support for fieldwork or for conferences. ⇒ For non-EU and non-EFTA grantees only: the FCS pays mandatory Swiss health insurance. ⇒ Scholarship holders from non-EU and non-EFTA countries receive a flight allowance (lump sum) for a ticket back to their country of origin (provided at the end of the scholarship). ⇒ Special CHF 300 housing allowance (paid once at the beginning of the scholarship). ⇒ One-year half-fare public transportation card. ⇒ Support services and various trips, dinners and sightseeing tours organised for Swiss Government Excellence Scholarship holders.
<b>Eligibility criteria and specific conditions</b>	⇒ Master's degree or equivalent university degree achieved <b>before 31 July 2022</b> (degree certificate completed) recognised by the Swiss university. As a proof, the degree has to be submitted to the Federal Commission for Scholarships before the start of the scholarship. ⇒ Applicant's date of birth after <b>31 December 1986</b> . ⇒ Applicants must provide a letter from an academic host professor (including her/his short CV) at the chosen Swiss university confirming why she/he is willing to supervise and support the PhD thesis. Without such specific support letter, the application will be rejected. ⇒ If an assistant professor supports a candidature, a full professor who is entitled to supervise the PhD during the entire scholarship has to co-sign the support letter. ⇒ Applicants must have a research proposal including a timeframe. This is the centrepiece of the application. The applicant must devote all required attention to it. ⇒ Applicants must be in command of the necessary language skills required for the PhD studies/ research. ⇒ Applicants who have been in Switzerland since more than one year at the beginning of the scholarship in September are not eligible. Reference document if applicable: residence permit to be added to the application documents. ⇒ Scholarship holders are expected to move to Switzerland during their grant period. ⇒ The scholarship amount covers the living costs of one person only. There are no additional family allowances. ⇒ Applicants who have already benefited from a Swiss Government Scholarship are not eligible to apply for a second scholarship. ⇒ <b>PLEASE NOTE:</b> ⇒ The FCS application for a PhD scholarship and the application for admission by a Swiss University for a PhD study are two separate procedures.

	⇒	The admission to a PhD study at your chosen Swiss University in due time is a <i>conditio sine qua non</i> for a potential attribution of a FCS scholarship - but no guarantee though for a positive decision by the Federal Commission for Scholarships for Foreign Students FCS. It is the applicant's responsibility to manage both procedures in parallel.
	⇒	A letter of support from a faculty member of the host university where the PhD is being completed is mandatory.
		<b>There are basically two different ways to achieve a doctorate degree (aka PhD).</b>
	⇒	1) The <b>first</b> way consists in undertaking <b>doctoral studies at a Swiss University under the supervision of an academic mentor (supervisor)</b> . In this case, the <b>admission to the PhD at the University might take place after the grant application period at the Swiss Embassy</b> . For your scholarship application you must hand in the support letter of your academic supervisor, however, an admission letter is not required.
	⇒	2) The <b>second</b> way consists in <b>being admitted to a doctoral school</b> , which provides the framework for the following doctoral studies. Please enquire all possible questions (e.g. your admission etc.) directly with the corresponding doctoral school. In addition to all other application documents (including the support letter from a supervisor), the <b>admission letter from the doctoral school is required with the application dossier</b> . As this takes time, applicants must plan accordingly and submit their application for admission to the doctoral school sufficiently in advance of the scholarship programme deadline. Please note: If the chosen doctoral school does not allow you to contact a supervisor before being admitted to the school, the application for the Swiss Government Excellence Scholarship is not possible.
<b>Selection criteria</b>	⇒	The following aspects and selection criteria are primarily considered:
	⇒	The candidate: academic profile, research capacity and motivation.
	⇒	The research project: originality and methodological soundness.
	⇒	The academic context: quality and context of supervision and potential for future academic cooperation.
<b>Application timeframe</b>	⇒	Opening of the call: 01 August 2021
	⇒	Application deadline: 12 November 2021
	⇒	Beginning of the scholarship: <b>01 September 2022</b>
<b>Application procedure</b>	⇒	The application package can be obtained by e-mail from the Embassy of Switzerland in Pyongyang.
<b>Application documents</b>	⇒	Please submit 2 sets (=1 original + 1 copy) of application documents in exact order given below: The 1 <sup>st</sup> set contains the original, <b>signed</b> documents plus the confidential letters of recommendation and, if applicable the attested translations in English. The other set is the copy of the 1 <sup>st</sup> set except for the confidential letters of recommendation (only 1 <sup>st</sup> set). No copies for 2 <sup>nd</sup> set.
	1)	<b>Signed FCS application form</b> (typed and printed) with photo.
	2)	A full CV with list of academic publications, awards etc.
	3)	A motivation letter (max. 2 pages).
	4)	A complete research proposal (max. 5 pages, <b>signed</b> ), using exclusively the FCS research proposal form.



- 5) If you undertake doctoral studies at a Swiss University under the supervision of an academic mentor (supervisor) : A copy of the letter from an academic host professor (including her/his short CV) at the chosen Swiss University confirming why she/he is willing to supervise and support the PhD thesis is mandatory. An admission letter is not required.  
**Applicants for doctoral schools (doctoral programmes) :**  
A copy of the letter from an academic host professor (including her/his short CV) at the chosen Swiss university confirming why she/he is willing to supervise and support the PhD thesis is mandatory as well.  
**In addition** to all other application documents, the admission letter from the doctoral school is required with the application dossiers.
- 6) Two confidential letters of recommendation from two different professors in the applicant's field (use exclusively the FCS reference form – originals in sealed envelopes only for the 1<sup>st</sup> set), no copies for 2<sup>nd</sup> set.
- 7) Photocopies of certificates and grade sheets from previously attended universities/colleges and diplomas with grades, starting with the most recent. If not in English, French, Italian or German with attested certified translations in English. Do not submit the original certificates.
- 8) **Signed** medical certificate (use only the FCS health certificate form).
- 9) Two copies of the applicant's passport (main page with personal data). Dual nationals add copies of both passports. Applicants already in Switzerland during the application procedure add a copy of the residence permit for Switzerland.
- ⇒ **Please do not put the documents into plastic folders or binders nor use paper clips or stapler.**
